### RETURN OF POTATOES BOUGHT FOR HUMAN CONSUMPTION

## Section 1: Use of Information

Under the Agriculture and Horticulture Development Board Order 2008 ("the Order"); if you are required to pay levy as a Potato Buyer, you must notify the Agriculture and Horticulture Development Board (AHDB) each month of your tonnage purchases of potatoes using this return form.

The tonnage information in Part 1(a) will be used for calculating the levy payable under the Order. This will be invoiced quarterly, in arrears, and will fall due on 31 December, 31 March, 30 June, 30 September.

The monthly tonnage and stock information will be used by the AHDB Potatoes for collecting and formulating statistics.

N.B: It is in your interest to submit the return promptly, in order that levy can be charged at the normal rate on the true tonnage. Otherwise the tonnages will be estimated by AHDB, based on information in its possession and invoiced at a higher rate.

#### Penalties:

It is an offence under the Order to fail to complete the return, or to give false or misleading information. AHDB has the power to make estimates where no proper return has been submitted. You will then have 28 days to provide a return, or the estimated levy will become payable. In either case the higher levy rate will apply.

### Section 2: Notes on Completing this Return

#### Part 1 - purchases

#### 1(b) - first purchases

In the next two columns, please enter potatoes bought direct from growers in Great Britain, old and new crop as appropriate.

## Part 2 - stock of potatoes for human consumption

Please enter the total weight of potatoes in stock or in transit to you at the close of business at the end of the month in question.

N.B. DO NOT INCLUDE potatoes of your own production which are still on your farm, or seed, or stock feed, or imported potatoes.

## Section 3: Have you bought potatoes in the course of your business as a retail seller or caterer?

If yes, when completing Part 1 (columns 1-4) of the return, please include only potatoes purchased direct from Growers. All Potatoes bought otherwise than for sale by retail or as a caterer must be returned irrespective of the source.

# **DEFINITIONS**

**Buyer** – this means a person who buys 1,000 tonnes (one thousand tonnes) or more of potatoes grown in Great Britain in any year ending 30 June.

Co-operatives of potato growers are exempted from paying Potato Buyer levy on purchases of their members' potatoes but must include potatoes bought from other sellers.
