EXPLANATORY NOTES

5. Neither the efficacy nor the phytotoxicity of the product for which this Extension of authorisation has been granted has been assessed and, as such, the user bears the risk in respect of failures concerning its efficacy and phytotoxicity.

ADVISORY INFORMATION

IMPORTANT: When applying this product under the terms of this Extension of Authorisation, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognised anti-resistance strategy.

This Extension of Authorisation relates to the use of 'Microthiol Special' (M19419) for the control of powdery mildew and Rust mite (*Aculus species*) on tomato (permanent protection with full enclosure). Applications to be made via conventional hydraulic spray equipment including air-assisted sprayers, vehicle-mounted or remote boom sprayers and hand-held sprayers including knapsack, hand-held lance and pedestrian controlled boom sprayers. Application should be made in a volume of 10 g of product per 5 litres water, with a maximum water volume of 2500 L/ha.

The use of this product in recirculating water systems in a glasshouse may result in dilute pesticide waste that requires disposal. All dilute pesticide waste must be disposed of safely and legally to protect humans, wildlife and the environment, especially groundwater and surface water. Pesticide disposal advice is detailed in the 'Code of Practice for Using Plant Protection Products (Section 5: Disposing of Pesticide Waste).

APPENDIX 1: CONDITIONS OF EXTENSION OF AUTHORISATION

The conditions below are obligatory. They must be complied with when the Extension of authorisation occurs. Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution. For the purposes of this Extension of authorisation only, the conditions and/or requirements shown below supersede any corresponding conditions and/or requirements set out on the label or otherwise provided for under the product authorisation **which would otherwise apply**.

Operator Protection:

- (1) Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment:

Operators must wear suitable protective clothing (coveralls) and suitable protective gloves when applying using pedestrian-controlled equipment with vertical boom or where contact with treated foliage is unavoidable during application in protected situations.

- (2) Broadcast air assisted sprayers must only be used where the operator's normal working position is within a closed cab with a suitable in-cab filtration system* during application in protected situations.
*Closed cabin meeting at least EN 15695 category 3.

- (3) Operators must only use vehicle mounted or trailed horizontal or vertical boom sprayers where the operator's normal working position is within a closed cab with a suitable in-cab filtration system* or suitable respiratory protective equipment** must be worn during application in protected situations.
*Closed cabin meeting at least EN 15695 category 3. **Disposable filtering facepiece respirator to at least EN149 FFP3 or equivalent.

Other specific restrictions:

- (1) This product must only be applied in accordance with the terms of this extension of authorisation, the product label and/or leaflet and any additional guidance on extensions of authorisation.
- (2) The maximum concentration must not exceed 10g product/5 litres water.
- (3) A minimum interval of 7 days must be observed between applications.
- (4) This product can be applied with an approved non-ionic wetting agent and when applied with such a wetting agent the concentration must not exceed that recommended on the label or List Entry for that wetting agent.
- (5) Treatment must only be made under 'permanent protection' situations which provide full enclosure (including continuous top and side barriers down to below ground level) and which are present and maintained over a number of years.
- (6) Reasonable precautions must be taken to prevent access of birds, wild mammals and honeybees to treated crops.
- (7) To minimise airborne environmental exposure, vents, doors and other openings must be closed during and after application until the applied product has fully settled.

APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION

Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution.

Adverse effects:

The authorisation holder must immediately notify the Secretary of State, the Scottish Ministers and the Department of Agriculture, Environment and Rural Affairs in Northern Ireland (care of the Health and Safety Executive), if they have any new information on the potentially adverse effects of the authorised product, or of residues of an active substance in that product when used in accordance with the conditions of this Extension of authorisation. For those products authorised under Regulation (EC) No 1107/2009 authorisation holders must also tell the other relevant competent authorities of the EC Member States (a list of which is available from the Health and Safety Executive) and the EC Commission. Failure to comply with this requirement is an offence.

Provision of information:

The authorisation holder must comply with all requests for information required by, or on behalf of, the Secretary of State, the Scottish Ministers or the Department of Agriculture, Environment and Rural Affairs in Northern Ireland in accordance with Regulation (EC) No 1107/2009.
